Are you sure? The problem definition will help you to determine	STAKEHOLDERS Who are the main users/targetgroups/stakeholders for this technology? Think about the intended context by When thinking about the stakeholders, the most obvious one are of course the intended users, so start there. Next, list the stakeholders that are directly affected. Listing the users and directly affected stakeholders also gives an impression of the intended context of the technology	SUSTAINABILITY In what way is the direct and indirect energy use of this technology taken into account? One of the most prominent impacts on sustainability is energy efficiency. Consider what service you want this technology to provide and how this could be achieved with a minimal use of energy. Are improvements possible?

For example: - Data is always subjective; - Data collections are never complete; - Correlation and causation are tricky concepts; - Data collections are often biased;	FUTURE What could possibly happen with this technology in the future?
