STAKEHOLDERS

FUTURE



een lange termijnstrategie voorzien waarbij de AI-coach ook op andere platformen kan worden geïntegreerd en kan samenwerken met educatieve instellingen voor bredere gedragsverandering en digitale gezondheid.

PRIVACY



Een instellingenmenu toevoegen waarin gebruikers zelf kunnen aangeven welke type data verzameld mag worden (bijv. kijkgedrag, reacties, schermtijd). Voeg daarnaast een automatische reminder toe om je data-instellingen elk kwartaal te controleren.
